

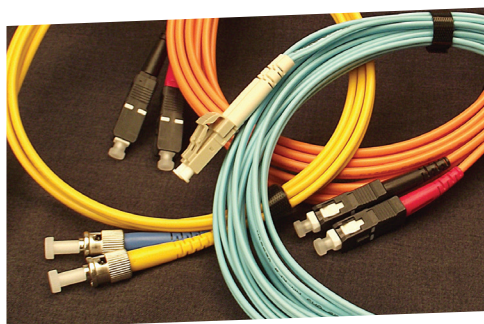


# LOGISTICAL STOCK ON BOTH COASTS

Shaxon does not charge drop ship fees from either our California or Florida warehousing facilities. Our goal is to provide the most transparent nationwide availability of product for our customers.


